The Multistate Bar Examination (MBE) portion of the exam accounts for 50% of the total score and is a nationally administered, 200-question multiple choice exam. As of February 2007, only 190 questions are scored, and the other 10 are unscored experimental questions used to gauge their appropriateness for future exams.
