Some decisions that may require an ordinary resolution include: election/re-election of directors, appointment of auditors, acceptance of financial and directors report at the general meeting, appointment and removal of directors .

Where a Directors' meeting cannot be held, the same matters can be authorized by the Directors' resolution that is signed by all the directors. Directors supervise the management of the corporation and make all major decisions for the corporation.

A general statement about the board meeting to decide on the following is also a part of a board resolution template. The biggest part of the board resolution template is the area to place what topics need to be decided on and what actions the company will take to resolve them. At the end of the document, each member of the board signs and dates their name. Some board resolution samples may also include a place where they can print their name.
