California Style Manual Legal Citations

CSM places the date parenthetical for cases, books, and law review articles after the case name or book or article title, instead of at the end of the citation. For California state cases, CSM requires you to cite the official reporters (Cal., Cal.App., Cal.App.Supp.), whereas the Bluebook requires you to cite West's National Reporter System (P. and Cal. Rptr.).

California has its own style manual for its state courts. Court cases are often published by more than one publisher, so there can be more than one citation appearing after the name of the case. Usually, the first citation given is to the official reports for a particular court, and is called the "official citation".
