Higher rate tax payers will pay a total of 32.5% tax (or more if a 50% tax payer!) on dividend income that falls above the basic rate Income Tax limit but because the first 10 per cent of the tax due on dividend income is already covered by the tax credit, in practice only 22.5% is owed. PAYE. PAYE (Pay as you earn) is a system of collecting income tax and national insurance from your wages, salary or occupational pension. This means that such amounts are received net of tax.
